LETTER FROM THE EXECUTIVE DIRECTOR

Dear Friends,

2021 was another challenging year for everyone. For the children and families served by Voices for Children, CASA, the uncertainties of continued COVID-19 concerns were amplified. In response, our CASAs advocated for creative solutions to address the ever-changing landscape. From arranging outdoor visits to facilitating online story time, our CASAs continued to press-on to ensure the children we serve were not overlooked during the pandemic. Our CASA Volunteers provide a consistent presence and promote nurturing relationships for the child, while helping to find, engage, and strengthen the support network for the child and their family.

Last year, CASA celebrated 225 children's case closure - children who were reunified with their family, adopted, or permanently placed within a loving family. Thanks to the overwhelming support of our community, 597 children from the seven counties we serve had a CASA Volunteer to ensure their best interests were heard in 2021.

Dedicated staff and supporters continued to participate in planning and attending our fundraising events, special projects, and awareness campaigns. After sprinting through the Superhero Fun Run, Voices for Children hit a hole in one with our annual Golf Tournament. Our Holiday Drive supplied children and families with needed essentials, while our Shop for CASA annual school clothing drive ensured the children we serve started the school year in style.

I could not be prouder of our advocates, staff, and supporters. Through countless hurdles and by carving out new paths, our organization was able to thrive and continue to be a strong and steady presence for the children in our care. To our staff, thank you for your dedication to this organization. To our supporters, thank you for believing in our mission. Lastly, to our CASA Volunteers, thank you for persevering through it all to provide children with the best possible advocacy.



"There are times when a teenager is thrown into the foster care system that will result in them "aging out" before the life of the case ends, even while their younger siblings remain in care. This can be not only very troubling for the teen but can create an added strain on the bonds between siblings placed in different homes. Such was a case I worked a few years ago involving 5 siblings.
